### **BEST DEFENSE, GOOD OFFENSE**

One of the casualties of the recent budget battles was former House Majority Leader Steny Hoyer's proposal for government to pay 80% of our health care premiums—the standard for the private sector—instead of the current 72% average which declines to 67% for those with Blue Cross Standard. Another casualty was premium conversion for retirees.

The Deficit Commission proposals would severely impact active federal employees as well as retirees — a 3-year freeze in federal salaries, a 10% reduction (3 leave; 2 replace) in the federal work force, computing retirement annuities based on high five rather than high three, and increasing retirement contributions from 1/4 of salary to 1/2. Retirees would not escape either. The debt commission proposals eliminate the government contribution to health care premiums and replace it with a deduction based on the Blue Cross Standard premium. They eliminate first-dollar coverage on medi-gap universal co-pay and place a catastrophic cap on Medicare parts A & B. They advocate a chained COLA which would reduce COLA increases for retirees by 3% over a 10-year period. If this were not enough, proposals from the House of Representatives would eliminate within-grade increases and generate a pay freeze for 5 years and cut the federal workforce by 15% (2 leave; one replaces) over 10 years. They would mandate 2-week furloughs and prohibit federal workers from serving as union officials on government time.

There is an urgent need to fight such proposals, which are based on a lot of false information about Federal Salaries and the Retirement System. The claims by some that the average

Federal worker makes \$120,000 or even \$74,000 a year are without foundation. The latter figure is based on Bureau of Economic Data on Federal Salary Accounts that does not factor out the cost of annuities which each federal facility is responsible for and is included in their salary account. One-half of Federal employees work in the nine highest paying occupations as opposed to less than one-third of private sector workers. For accurate, non-partisan information, go to President's Pay Agent <a href="http://www1.opm.gov/oca/">http://www1.opm.gov/oca/</a> payagent/2009/message.asp. They compare pay for similar occupations—federal versus private and illustrate that we earn 24% less than the private sector. Unlike the Social Security System, the Civil Service Retirement System is solvent. Over the next 10 years, Social Security will take up another 2% of GDP, but the Civil Service Retirement will decline by 0.06% of GDP over the same 10 years.

If the House proposals go through and Defense and Homeland Security are exempt from cuts, this would mean a 42% cut in every other agency which would impact Social Security benefit claims, food safety, FBI, drug enforcement—just to name a few. If spending is cut this much and staffing is reduced, the question for these lawmakers is, "What services will you cut?" The March 5-8 NARFE Legislative Conference will address these issues. I will attempt to obtain a record of the proceedings to share with you. As Joe Wahlen, our 3rd District VP, pointed out, NARFE is going to hire a public relations firm to help get out an accurate picture of the Federal workforce and the Civil Service Retirement System. In January, psychologist, Dr. Ryan Wetzler, one of only 150 people certified in Behavioral Sleep Medicine in the U.S. and one of two in KY, spoke about the benefits of good sleep and how to get it without pills. In February, Bob Mueller of Hosparus, spoke on the six mistakes people make in life and gave insights for overcoming them—the same six Roman orator Cicero named 2,000 years ago in his "Six Mistakes of Man." In March, Kelley Wilkerson, Associate Curator at Frazier International History Museum, previewed Frazier's 2-years-in-the-works exhibit set to open in October. Exhibits will bring to life the pathos of the Civil War in border state Kentucky. The Exhibit runs through April 2012 and is titled "Civil War: My Brother, My Enemy."

# FIVE OF SIX KY REPRESENTATIVES SUPPORT FEDS' STEP INCREASES

On February 16, NARFE President Joe Beaudoin sent a letter to all 435 Representatives urging them to vote "NO" on amendment #569 to H.R. 1 offered by Rep. Darrell Issa, R-CA. The Issa amendment went beyond the current two-year federal pay freeze by banning step increases as well. On February 19 all of KY's Reps, except Edward Whitfield in District 1, voted "No" on this amendment — <u>i.e., five voted to support federal employees.</u>

Mr. Issa's amendment failed by a vote of 191-230.

You, like many of us, were probably blindsided by the sudden increase in Federal withholding tax deducted from your annuity due to the demise of the "make work pay" law which reduced the formula for taking federal taxes out of our annuities. Many of us have far too much withheld and have to wait a year to get it back. No interest of course. The amount of your total tax owed at the end of the year is not affected—simply the amount withheld each month.

Dave Snell, who heads the NARFE Benefits Department, reports that the Office of Personnel Mgmt. (OPM) has established a new toll-free line retirees can call to reduce the amount of Federal tax withheld from their monthly annuity. The # is 1-800-307-8298.
